## SHOTGUN RANGE ORIENTAION

## THE FOLLOWING RULES MUST BE FOLLOWED WHILE USING THE RANGE

- All range users and shooters are responsible for range safety and safe shooting. Anyone may call
  a "Cease Fire" at ANYTIME if an unsafe condition occurs.
- When instructed to "Cease Fire", shooters will immediately stop shooting and unload shotguns.
- All range users and shooters are responsible to immediately correct any unsafe condition.
- All range users must immediately report any unsafe condition to a Range Safety Officer (RSO).
- Shooters are required to participate in a safety orientation before shooting for the first time or have a Hunter Safety Certificate.
- Uncased guns must be carried with the breech open and empty with muzzles pointed up, unless it
  is a break open gun, whereas the muzzle may be pointed down.
- · All persons on the shotgun ranges must wear ear and eye protection.
- The practice of resting the muzzle of a shotgun on a shooter's toe is discouraged.
- · Users must not point firearms at anyone at any time.
- Shooters must only carry ammunition for the firearms utilized. Only 7 ½, 8, or 9 shot is permitted in lead. Slugs, heavy buckshot, and steel shot are prohibited.
- All guns must have the action opened and contain no live or empty shells at any time, except when the shooter is at the shooting station.
- Shotguns may only be loaded while at the shooting station, and must be pointed towards the target area only.
- · Release-type triggers are not permitted unless the RSO is notified before loading the gun.
- Empty shell casings will not be picked up from the ground until all shooting is completed.
- A break open gun's action may be closed when it is in a gun rack but it shall not contain a live or empty shell.
- Spectators and children under 5 years of age are not allowed on the fields during shooting.
- Only individuals with a disability may shoot from a seated position or shooting cart.
- All shooting will be in authorized area and only at targets authorized by Waukesha Gun Club Inc. Staff.
- Deposit all trash in containers and cigarette butts in appropriate receptacles.
- Respect others and all equipment.
- Alcohol and drugs are prohibited on all ranges.
- Individuals who have been consuming alcohol or are under the influence of drugs are prohibited from shooting.
